Behaviour and Discipline

Rules and Regulations:

- Any student who is persistently insubordinate or is repeatedly or willfully mischievous, or is guilty of gross malpractice in connection with an examination or of unauthorised alterations in a mark sheet or leaving certificate, or who in the opinion of the Principal/ Headmistress has an unwholesome influence on his/her fellow students may be removed from the rolls. Irregular attendance, habitual negligence in work, dishonesty, obscenity in word or act, insubordination, serious misconduct or threats, even outside the school, are sufficient reasons for dismissal.
- Any student caught indulging in any form of malpractice during the examination will be prohibited from continuing to appear for said paper and will not be allotted any marks for the same. He / She will not be allowed to attend the subsequent paper too.
